**Assumption of Risk and Waiver of Liability.**

In consideration of my involvement with the Falcon Field Airport Open House, I hereby release and agree to defend, indemnify and hold harmless the City of Mesa, its officers, volunteers, directors, officials, representatives, elected officials, employees and agents (collectively, the "Event Organizers") from any and all liability and negligence for any damage or injury which may occur to myself or third parties, regardless of the cause, that may result from participation in the Falcon Field Airport Open House. This release of liability and agreement shall apply to any claim, demand, suit or right of action that might accrue to myself, my heirs or my personal representatives, including claims of negligence. Further, I agree to assume all risks in participation and am fully aware that personal danger may be involved in this activity.

My waiver and release includes, but is not limited to, the Event Organizers' negligence in: rescue operations, adequacy of facilities and provisions, site preparation, training and instructions to volunteers, interpretation and enforcement of rules, provisions of medical or emergency medical assistance, or supervision of and safety for the volunteers.

I am (or my child is) physically capable of volunteering for this event. I do not expect the Event Organizers to supervise, instruct, or train me (or my child). I further agree that if at any time I believe conditions to be unsafe, I will immediately discontinue my (or my child's) further participation in the event.

This assumption of risk and waiver of liability is intended to be as broad and inclusive as permitted by the laws of Arizona. If any portion of this document is held invalid, the remainder shall continue in full force and effect. I understand that at this event and related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the Event Organizers.
